## **Relevant News**

#### Look at the thermometer!!!

Wow, it is hot and when it is hot, things start to happen. Remember, some products should not be applied when temperatures exceed 85°F. When temperature are high, many pesticides can burn tender plants. Also, some formulations, such as E and ECs may burn due to their rapid rate of absorption into the plant. The best practice to prevent problems is to read the pesticide label prior to purchase, mixing and/or applying any product. This keeps you ahead of any possible problems that may occur. Hot temperatures as well as low relative humidity and wind can cause products to volatilize and move off target, so be careful and read the label as well as become familiar with the characteristics of products you use. Herbicides containing active ingredients such as 2, 4 –D, 2, 4-DB, MCPA and dicamba are known to be easily effected by hot weather. So take extra precautions when using products containing these active ingredients. The Soil, Plant Pest Center located in Nashville commonly receives plants which have damage due to individuals who have used products containing glyphosate. Yes, glyphosate can cause unwanted damage when weather conditions are hot. Also, for some products to work effectively, they must be incorporated into the soil, and if they are not, may also cause some unwanted damage. The best practice is to read and follow the label prior to all applications.

#### Managing Nitrogen with Scattered Rainfall Conditions

With recent weather events in the Midwest, corn prices have started to climb and growers are paying closer attention to protecting corn yield. In the past month, rainfall in Tennessee has been much more scattered to practically nonexistent and we aren't used to these dry spells compared to past years. Most of the calls I have had this week, dealt with concerns about nitrogen applications that went out prior to a 2 to 3 (or more) week dry spell. Surface N applications that go without an incorporating rain cannot benefit the crop. Rainfall helps move soil applied N through the profile and stimulates crop root growth for uptake. Fortunately, with warm weather and adequate subsurface moisture, nitrogen is mineralized from organic matter and smaller corn has a low N requirement. But, requirements are increasing greatly as we move into June.

#### For surface N that has gone out:

- Irrigate N in by applying at least 0.25" water. For granular urea or UAN with no NBPT (Agrotain) stabilizer, apply irrigation within 2 days of fertilizer application.
- In dryland fields, document application date and date of first incorporating (0.25 or more) rainfall event. If more than 3 weeks have passed, consider topdressing an additional 30 to 40 units of N in fields with expected good yield potential. For fields in 'dry zones' that continually miss rain, we may need to reduce our yield goal and manage for lower yield.

#### If sidedressing N in dry conditions:

- Granular material can more easily slide through surface residue versus UAN. Apply NBPT stabilizer to granular urea. This will buy a few
  weeks protection from surface volatilization loss and 'wait' on an incorporating rain. Check labeled rates of some generic products and make
  sure to apply the higher end rate.
- Do not broadcast UAN. It will adhere more to surface residue than granular material, increasing likelihood of surface volatilization loss without timely rain. Instead, inject or spray down into the soil behind a coulter or dribble/spray in a narrow band to minimize surface area exposed to volatilization loss. Add NBPT stabilizer to surface applied UAN if rain is not expected within a few days.

On May 1, 2019, a group of individuals representing Southern Crop Production Association (SCPA) travelled to Washington D.C. to meet with lawmakers concerning several important agricultural topics. TAPA selected Guy Spence to represent our association on the Hill visit. SCPA Team Members from Tennessee included **Guy Spence (TAPA)**,

At each office, PRIA, ESA, FIFRA, and Transportation Reform were discussed. The group thanked them for passing PRIA (Pesticide Registration Improvement Act) in March of 2019. PRIA created regulatory certainty for registration timelines for the pesticide industry. They also asked the lawmakers to continue funding this act, and informed them about how the ESA (Endangered Species Act) is the greatest challenge to the pesticide industries ability to bring technology to agriculture. The leaders were also informed of our support of FIFRA (Federal Insecticide Fungicide and Rodenticide Act), and explained how it relates to ESA. Lastly, Transportation Reform was discussed. Within Transportation Reform is the Drive Safe Act which would create an apprenticeship training program allowing legal operation of commercial motor vehicles by CDL drivers between the ages of 18 to 20 in interstate commerce.

TAPA is thankful for Guy's willingness and enthusiasm about making the D.C. visit. What a great opportunity!



## UT "Weed Tour " at West TN Research and Education Center: June 19

The University of Tennessee Weed Tour will be held Wednesday, June 19 at the West Tennessee AgResearch & Education Center in <u>Jackson, TN (605 Airways Blvd)</u>. Registration will start at 8:30 A.M. and the tour will begin at 9:00 A.M. It will end about 11:30. We will have breakfast biscuits available before the tour starts.

This guided tour will cover 60 weed management research tests in corn, soybean and cotton. Most of the research shown will be on management of glyphosate resistant horseweed and Palmer amaranth. Management

of these weeds in Liberty, Balance Bean, glyphosate, Xtend and Enlist weed control systems along with some of the new herbicide technology traits on the horizon in cotton and soybeans will be highlighted. Also, some strategies to manage the increasing problem with glyphosate-resistant grass species as well as glyphosate/PPO resistant Palmer amaranth will be discussed.

Moreover, cultural weed control practices and many of the newer premixes in corn and soybean will be demonstrated. Ph.D candidate Clay Perkins, myself and our very special guest, Dr. Travis Legleiter, weed scientist with University of Kentucky, will lead the tours and be available for consultation as well as discussion of issues and product performance.
