Can New Rules Affect You? By Dr. Darrell Hensley



On August 24, the Environmental Protection Agency (EPA) released a proposed rule titled Pesticides: Certification of Pesticide Applicators, (RIN 2070-AJ20)" FRL: 9931-83, Docket no. EPA-HQ-OPP-2011-0183. The official version of the document is published in the *Federal Register* and a PDF version may be found here: http://www.gpo.gov/fdsys/pkg/FR-2015-08-24/pdf/2015-19988.pdf

The EPA is proposing changes to the existing regulation concerning the certification of applicators of restricted use pesticides (RUPs) in response to extensive stakeholder review of the regulation and its implementation since 1974. EPA's proposed changes would ensure the Federal certification program standards adequately protect applicators, the public, and the environment from risks associated with use of RUPs. The proposed

changes are intended to improve the competency of certified applicators of RUPs, increase protection for noncertified applicators of RUPs operating under the direct supervision of a certified applicator through enhanced pesticide safety training and standards for supervision of noncertified applicators, and establish a minimum age requirement for certified and noncertified applicators. In keeping with EPA's commitment to work more closely with Tribal governments to strengthen environmental protection in Indian country, certain changes are intended to provide more practical options for establishing certification programs in Indian country.

Who will the new ruling affect? Anyone who applies a restricted-use pesticide (RUP) or agency that administers certification programs or pesticide safety educators. For Tennessee, this means all private applicators and commercial applicators who apply restricted use pesticides, the Tennessee Department of Agriculture and the University of Tennessee's Pesticide Safety Education Program.

Comments to EPA must be received on or before November 23, 2015.

USDA, TDA ANNOUNCE SEED FUNDING TO IGNITE AGRI-TECH ENTREPRENEURSHIP

NASHVILLE — The next great business idea just may come from rural Tennessee. USDA Rural Development and the Tennessee Department of Agriculture today announced \$220,000 in combined seed funding for a new initiative to help make Tennessee a hub of agri-tech innovation and entrepreneurship.

The Department of Agriculture will facilitate the program, known as AgLaunch. Led by Memphis Bioworks Foundation, the program will also include participation from the Tennessee Department of Economic and Community Development and the University of Tennessee Institute of Agriculture. AgLaunch is an ambitious effort to attract 200 entrepreneurs and establish 100 successful and investable agricultural-sector companies in Tennessee by 2020.

AgLaunch will seek to identify early stage agri-technologies and companies and assist them in building investable, high-growth enterprises through mentorship and programming. Bioworks is currently working with investors and seeking a total of \$10 million in public and private funding over the next five years for the project. The goal is to initiate AgLaunch in 2016.

Tennessee Commissioner of Agriculture Julius Johnson, U.S. Rep. Stephen Fincher, USDA Rural Business-Cooperative Service Administrator Lillian Salerno and Tennessee State Director Bobby Goode joined officials for the announcement at the Mid-South Family Farms office in downtown Ripley, Tenn. Mid-South is a third generation diversified farming operation that utilizes the latest technologies to increase productivity and lower inputs. The event included demonstrations from startup companies AgSmarts, Granular and FarmSpace.

"Ag innovation and business creation have the potential to transform our rural economy more than anything else," Commissioner Johnson said. "We've got to be a player if we're going to fully participate in the growing world demand for food, fuel and fiber. With this funding, we expect to incentivize private investment while making Tennessee a center for agricultural advancement." State and federal agricultural officials say that Memphis Bioworks' exemplary track record in bringing entrepreneurs to the market-place in the medical technology sector is what attracts their agencies to invest in this project.

The impetus for AgLaunch comes from Gov. Bill Haslam's Rural Challenge, a 10-year strategy to expand the agricultural and forestry sectors of Tennessee's economy, currently valued at \$66 billion.

Industry, Environmentalists Question EPA Assertions In Pollinator Proposal

Industry and environmental groups are both faulting assertions in EPA's proposal to protect pollinators from acutely toxic pesticides, with advocates questioning an agency statement that exposures of native bees to pesticides are "less certain" than for managed bees under contract for pollination, and industry seeking evidence for claims of bee kills.

EPA is currently taking comment through Aug. 28 on the proposal that would limit certain applications of dozens of active ingredients and affect several thousand products. The May 29 proposal is part of a broad federal effort to implement President Obama's June 2014 memo for improving bee health by restoring habitat, assessing risks to bees from pesticides and other stressors, and acting where appropriate. EPA's proposal would prohibit foliar applications, during bloom, at sites where bees are contracted for pollination, and would encourage states to craft pollinator protection plans for protecting managed bees at or near other sites. The two-part plan hinges on assertions that acutely toxic pesticides have caused bee kills, and that such incidents are more likely to occur where managed bee colonies are brought on site

for contract pollination services.

EPA Aug. 13 published on a federal website data on reported bee kills after industry groups, including the pesticide producers coalition CropLife America, questioned EPA's assertion in the proposed rule that restrictions are needed to prevent bee kills from pesticide exposure.

According to a July 16 letter from EPA to CropLife, the agency provided the data in response to a Freedom of Information (FOIA) request from the industry group. A spreadsheet from the agency's Ecological Incident Information System lists more than 1,000 reported bee kills, associated with a variety of pesticides, dating back to 1985. The agency's release follows a July 13 letter from more than a dozen industry groups, including the American Farm Bureau Federation, the American Seed Trade Association and the National Corn Growers Association, arguing that EPA based its proposal on incidents of pesticide -related bee kills yet had declined requests for information backing the claim.

The groups requested a 60-day extension of the comment deadline to allow time for EPA to process the FOIA requests, and for industry to analyze the data. In response, EPA allowed an additional 30 days, extending the deadline to Aug. 28. Still,



some groups filed comments in advance of the prior deadline.

U.S. Apple said,"This 'one size fits all' prohibition does not allow growers the flexibility for use of individual, effective products with the appropriate best management practices (BMPs). We urge the EPA to adjust the proposal to provide flexibility in the label language, which will allow the products to be applied and BMPs to be implemented when pest infestations occur during bloom period for crops under contract pollinator services."

U.S. Farm Sector Profitability

The USDA Economic Research Service (ERS) has issued its updated 2015 outlook for net farm income which is forecast to be "... \$58.3 billion in 2015, down 36 percent from 2014's estimate of \$91.1 billion. The 2015 forecast for net farm income would be the lowest since 2006 (since 2002 in inflation-adjusted terms) and a drop of nearly 53 percent from the record high of \$123.7 billion in 2013 ... Crop receipts for 2015 are expected to decrease by \$12.9 billion (6.2 percent) in 2015 ... Livestock receipts are forecast to decrease by \$19.4 billion (9.1 percent) in 2015 largely due to lower milk and hog prices ... Farm asset values are forecast to decline by 3.5 percent compared to 2014, and farm debt is forecast to increase by 5.8 percent ..."

Dow AgroSciences' Enlist[™] system records a big year, looks ahead

In fall 2014, the U.S. Department of Agriculture deregulated the Enlist^w corn and Enlist soybeans traits. The Enlist cotton trait received approval in July 2015, completing the regulatory review process for all Enlist traits.

The U.S. Environmental Protection Agency also registered Enlist Duo for use with Enlist corn and soybeans in 15 states. Registration is pending for Tennessee and additional states as well as registration of Enlist Duo[™] herbicide for use on Enlist[™] cotton.

Dow AgroSciences launched Enlist Duo[™] herbicide with Colex-D[™] Technology this year in conjunction with a stewarded introduction of Enlist[™] corn, as well as seed production of Enlist soybeans — all of which are part of the Enlist Weed Control System. Monsanto's Bollgard II XtendFlex Cotton expected on over 750,000 acres

Company continues to move toward commercialization of next-generation soybean technology

Despite a reduction in cotton acres across the Belt, Monsanto sold out of Bollgard II[®] XtendFlexTM cotton in the United States as part of its commercial introduction in 2015, with planting estimated on more than 750,000 acres.

Bollgard II XtendFlex cotton is tolerant to glyphosate, glufosinate and dicamba herbicides. Growers were able to use glyphosate (Roundup[®] brand agricultural herbicides) and glufosinate (Liberty[®] herbicide) which currently have existing labels for over-the-top use on tolerant crops. Monsanto is still seeking EPA registration for dicamba as an in-crop herbicide, so over-the-top use of dicamba was not authorized for the 2015 growing season.

Monsanto continues to move toward the commercialization of Roundup Ready 2 Xtend[™] soybeans, which is tolerant to glyphosate and dicamba herbicides and could potentially be available in more than 60 varieties across eight maturity groups in 2016. In addition, farmers can look forward to improved resistance packages against nematodes and phythophthora root rot with these varieties. Along with Bollgard II XtendFlex cotton, this next-generation soybean technology is part of the Roundup Ready[®] Xtend Crop System, and pending regulatory approvals will provide farmers with more consistent, flexible control of tough-to-manage broadleaf weeds.

In January, the USDA finalized trait deregulation of Bollgard II XtendFlex cotton and Roundup Ready 2 Xtend soybeans. The next step in the approval process will be the EPA's draft label for dicamba use over the top of the new soybean and cotton products. This is expected to occur sometime in the near future, which will then start a public comment period for the draft label. Federal and state approvals are expected shortly after this public comment and review period.

Pending regulatory approvals, Monsanto is making plans to bring two low-volatility dicamba formulations to market in 2016. One is a pre-mix of glyphosate and dicamba (Roundup XtendTM herbicide with VaporGripTM technology) and the other is a dicamba solo product (XtendiMaxTM herbicide with VaporGripTM technology).
