MESSAGE FROM THE PRESIDENT **Jim Wills**

The 2007 Annual Meeting of the Tennessee Agricultural Production Association will be at the Edgewater Hotel in Gatlinburg on August

1-3. I encourage members, officers, board members and potential members to mark vour calendars now so that potential conflicts with other meetings and activities do not interfere with these dates.

TAPA conducted the 2007 Agronomic Workshop in Jackson on February 5-7 at the West Tennessee Research and Education Center. Program chairman Mark Spiller planned an excellent program and several excellent speakers provided some very useful and up-to-date information on a variety of topics. One hot topic of interest was the current push by the Bush Administration to replace much of our imported oil supplies with renewable fuels. Currently, there are 111 ethanol refineries in the U.S. producing about 5 billion gallons of ethanol annually. Another 80 or so plants are under construction or expansion. Estimates are that the ethanol industry will need another one billion bushels of corn in 2007-08 and much more than that in the next five years. This means that at least seven million more acres of corn are needed in 2007 over 2006 production. Are we moving too fast? Will there be enough corn to meet the demands of the ethanol refineries in the near future? Will the price for corn drive up corn based food products? Will switchgrass and wood cellulose conversion processes become cost efficient and take some pressure off of corn production

for ethanol? There are many more acres of land more suited to grass and wood production than to expanded corn production. As corn prices increase from about \$2.00 per bushel in 2006 to about \$4.00 per bushel now, more acreage is projected to be planted in corn this year and well into the future. Some of this new acreage will come from marginal land that has not been in recent production or is not capable of 150 bushel per acre yields. What effect will the increase in corn prices and acreage have on fertilizer availability and prices? The price for ethanol per gallon has been very volatile over the past several months with highs of \$2.50 per gallon to lows of \$1.70 per gallon.

Will there be a similar domino effect on other crop inputs? Several speakers at the Agronomic Workshop in Jackson spoke about fertilizer trends. For sure, nitrogen prices will continue to rise and the availability of other nutrients may be limited. With higher demand from other countries such as China, costs of fertilizers will surely increase and availability could be limited in some markets. The availability of railroad cars and barge scheduling for fertilizer transport will be a cause for concern in the future.

This discussion leads us to the very purpose of TAPA. As consultants and advisors, how can we assist our producers and customers to avoid shortages and exorbitant prices for crop production inputs? Should a given acreage be put into corn production or would it be better suited to a different crop? Are there better times of the year to purchase crop production products when prices may be a little lower and demand is not at peak?

Can we substitute nitrogen sources and still achieve good yields and quality? Do we need to apply as much total fertilizer as we have in the past? Will some lower cost pesticides give as good a control on specific pests as more expensive ones? Will soil testing save money on fertilizer needs? These and many more similar questions can be discussed and some solutions to these problems answered by speakers at TAPA meetings. If you miss a meeting, you may miss the answer to a burning question you have. See you at the annual meeting in Gatlinburg on August 1-3,2007

UT Weed Tour

The University of Tennessee Weed Tour will be Wednesday, June 13, 2007 beginning at 8:00 am at the West Tennessee Research & Education Center and concluding at Milan Research & Education Center with lunch in the West Tennessee Agricultural Museum.

There are approximately 40 experiments that attendees will be viewing during the tour. These will include burndown, early preplant, preemergence, postemergence, post-directed and lay-by trials on corn, cotton and soybeans. In addition, trials evaluating carryover to crops, residual activity, application timing, herbicide resistant crops and glyphosate-resistant horseweed will be viewed and discussed.. Plot plan books will be available for attendees.

UT personnel will be available for consultation and discussion of issues and product performance.

Points will be available for pesticide recertification. In addition, this event is being submitted to the Tennessee CCA Board for CEU approval.
